ANNOUNCEMENTS:

Clerk Hall thanked the board for their patience and understanding the last few months and also thanked them for the lovely plant received at her son's funeral. Trustee Whitcomb announced the Lions Club would be having their soup supper on Sunday February 19, 2023 from 10:30 am to 1:00pm at the Floral Hall.

MINUTES:

President Rogers stated there was a typo under water meters it shows "atraw" and should be "straw". Trustee Adams also noticed a typo under the Rebuild Illinois Fund it shows "ne" should be "be"

Trustee Brown made a motion to accept the minutes with corrections, 2nd by Trustee Simkins. All in favor, motion carried.

TREASURER'S REPORT:

Trustee Brown made a motion to accept the treasurer's report, 2nd by Trustee Simkins. All in favor, motion carried.

President Rogers stated under the water fund CD #32722 is up in March she then asked Treasurer Whitcomb what his recommendation is. Treasurer Whitcomb recommended letting the CD roll over.

Trustee Brown made the motion to let CD#32722 roll over, 2nd by Trustee Simkins. All in favor, motion carried.

BILLS:

President Rogers stated there are two bills that just came in. One is for Eagle Enterprise for the recycling bins and the other is for Blooms by Beck for the plant sent to CJ Hall's funeral.

While looking over the bills President Rogers noticed the Nova bill was only \$0.70 and asked Treasurer Whitcomb why it was only that much. Treasurer Whitcomb stated there was a credit on the account after the village went wireless and after the last of the credit that was what was owed. The bill is for the modem and is \$3.95 a month. It was discussed if the bill could be paid for the whole year instead of having such a small check each month. Treasurer Whitcomb stated the amount for the check can be changed to \$47.40.

Trustee Simkins made a motion to pay the bills with the two additions and the increase of Nova's to \$47.40, 2nd by Trustee Brown. All in favor, motion carried.

OLD BUSINESS:

President Rogers asked the board if they had any old business. With no old business the board continued on to the new business

NEW BUSINESS:

Street Signs:

President Rogers stated Ron Brown has some street signs and when the weather turns nice he will replace them, if more are needed he will inform her so more may be purchased. Trustee Brown made a motion to have an ad ran in the paper for mowing bids, 2nd by Trustee Adams. All in favor motion carried.
