Trustee Hoefer questioned the safety of hanging them in the park. He asked if the village is liable if some child would eat it. President Rogers stated that was a good question and asked Clerk Hall to contact the insurance company for guidance.

NEW BUSINESS

Clean Up Day

The board is looking into the possibility of a spring clean up day. Clerk Hall has looked into getting quotes from Jackson Disposal and Peterson Disposal. Clerk Hall reported Peterson's cost has went up from \$800.00 per truck load to \$1050.00 per truck load with the minimum being \$1050.00 and the can do it Friday May 7th also it is \$25.00 per appliance. Jackson's gave an estimate of \$1150.00. Clerk Hall continued to state this is only an estimate, it was figured on 75 residents. It could be less depending on how many people participate. Clerk Hall stated it would have to be on a Saturday because the rest of the week is for their normal route. It was asked if only say 5 residents participated is there a minimum charge. Clerk Hall answered they did not state one but she will call for more information.
