### Meters

Clerk Hall stated she spoke to the lawyer to see if it was legal to turn a person's water off if they will not let the village change out their meter. Clerk Hall then explained per the Village Water Ordinance, 2020-02 Section 8, the village has the right to turn off a person's water for noncompliance. Trustee Stage suggested, sending those who still have the old meters, a certified letter stating they have 30 days to contact Gary to make a date to change out the meter, then they have 30 days to complete it or the water will be shut off.

Trustee Brown made a motion to send the certified letter, 2<sup>nd</sup> by Trustee Stevens. All in favor, motion carried

### **NEW BUSINESS**

# Illinois Rural Water, Rural Water Impact and Central Square Renewal's

Clerk Hall stated these are the village's insurance, web site and billing program

Trustee Brown made a motion to renew all three, 2<sup>nd</sup> by Trustee Stevens All in favor, motion carried.

## **Return to Work Policy**

Clerk Hall stated this is a policy that is required by the insurance company. It is basically for those towns that have employees. It states that if anyone is off due to illness or injury they have to be released before coming back to full duty. It also gives examples for light duty. Clerk Hall stated if something was to happen to herself, Gary or even Bob it would not be covered by insurance without this policy.

## **Resolution Supporting the Ordering of Signs**
