**BILLS**

**Trees:**

The tree already has a large limb down and President Rogers is worried more will fall and someone could get hurt or it could cause serious damage.

President Rogers continued to state the other is right across the street, it is dead and should be removed. President Rogers recommended having Lee's Tree Service come out and remove them both. Trustee Stevens made a motion to have Lee's Tree Service remove the trees, 2<sup>nd</sup> by Trustee Brown. All in favor, motion passed.

**Christmas Activities:**

President Rogers asked the board if they wanted to do anything for Christmas. Several suggestions were made, one being having a tree that the residents could decorate again this year. President Rogers stated she donated the tree last year but with the cost going up she could not do it again this year. It was suggested to get an artificial tree that way the village would have one for every year, or even see if anyone had one to donate. President Rogers suggested decorating the bus stop and around the park. After more discussion it was decided the board would meet on Saturday, December 4, 2021 around noon to decorate the bus stop and the village park. It was then discussed to have the house decorating contest, with the prizes being: 1<sup>st</sup> place \$75.00, 2<sup>nd</sup> place \$50.00 and 3<sup>rd</sup> place \$25.00. The judging would be December 18, 2021.

Trustee Brown made a motion to decorate the village park on December 4, 2021 and the house lighting contest with the prizes being \$75.00, \$50.00 and \$25.00, 2<sup>nd</sup> by Trustee Stevens. All in favor, motion carried.
