Morales's Meter

Acting President Simkins turned the floor over to Mr. & Mrs. Morales. Mrs. Morales stated she hadn't received the estimates for the plumbers. Treasurer Whitcomb replied that the estimate is for the village. Mrs. Morales stated she hadn't received anything in writing as to who the village chose. their insurance and license. Clerk Hall stated there was nothing said about them getting anything in writing, also they will receive a copy when the plumbers come out. Clerk Hall continued to state Kevin from Tony's will be doing the work but needs to get with Treasurer Whitcomb as to when they can do it and Treasurer Whitcomb has been busy handling personal business for the last couple weeks. Clerk Hall let the board know that Kevin is willing to do the work for less than prevailing wage which is \$189.00.
